DECODING THE LEGAL JARGONS

De novo

- (*A new*)



De novo is a Latin term that means "anew," "from the beginning," or "afresh." When a court hears a case "de novo," it is deciding the issues without reference to any legal conclusion or assumption made by the previous court to hear the case. An appellate court hearing a case "de novo" may refer to the lower court's record to determine the facts, but will rule on the evidence and matters of law without deferring to that court's findings. A trial court may also hear a case "de novo" following the appeal of an arbitration decision

De novo review occurs when a court decides an issue without deference to a previous court's decision. Trial de novo occurs when a court decides all issues in a case, as if the case was being heard for the first time.

Trials de novo are **not common** due to the time and **judicial resources** required to try the facts of a case more than once. However, de novo review of legal matters on appeal is quite common.



Introduction

Every CA intermediate student has a dilemma whether to join in which domain during the articleship and some students even don't know what are the domains we can work in during articleship. So now I will cover some good stuff about the articleship domains in big4s and good mid size firms.



1. Statutory Audit

Statutory audit is one domain where most of the students join. During the tenure of articleship you can learn about statutory audit of various companies along with Tax audits, stock audits, limited reviews etc. You can study the financial statements of various companies and understand the businesses of various sectors. While joining for articleship in this domain in any firm, do look after the client base of the firm.

2. Internal Audit

Also known as Risk advisory is one of the domain which lets you know about the internal controls of the companies. The auditor's role is to check whether all the internal controls are in place. You can even join management consultancy firms through internal audit.

3. Direct Taxation

This is the domain where you learn various tax filings. One can get exposure of the tax computation, tax filing, tax advisory, tax structure, tax planning and tax litigation go for taxation. You can also choose transfer pricing or international taxation domains which are some of the evolving domains in recent times.

4. Indirect Taxation

With the introduction of GST, the domain got importance and this is one of the evolving domains in present scenario. We can get exposure regarding GST filings, GST audit, advisory and litigations in this field. We also get knowledge of customs duty related stuff.

5. Mergers and acquisition

In the present corporate world, companies are expanding through mergers and acquisitions. During the tenure of articleship we can learn some good stuff for restructuring, mergers, demergers and will learn tax due diligences. This gives an exposure to international way of working.

6. Transfer Pricing

With the globalization and increase in international transactions by MNCS, the scope of transfer Pricing is increasing. It deals with international transactions and taxation for such transactions.

7. Forensic Audit

Forensic audit is like an investigation to analyze and identify the evidences of frauds jn a company. It is one of the niche field which is growing in the recent times.

TESLA – How Green is the Future

Background

Whose year was 2020–2022 on Wall Street? It wouldn't be inappropriate to assume that it belonged to Tesla, managed by Elon Musk.

During that time, Musk and Tesla enjoyed a global run of success that made them the center of attention in every newspaper. Tesla Models X, 3, S, and Y have caught everyone's attention, have people hankering to get their hands on them.



Tesla with its headquarters in Austin, Texas, aims to build a world where all transportation is powered by electric vehicles, batteries, and solar energy, and it has made progressive steps in that direction.

Along with all the media attention it received, its stock movement from a paltry \$29.53 on January 3, 2020 to an astounding \$407.36 on November 5, 2021 attracted everyone's attention. Very few firms throughout the world had experienced that amount of rise in their share price.

Just as everything was going perfectly for Tesla, its shares plunged by a staggering 72% from its peak in 2021 to \$123.51 on December 30,2022. Tesla's market cap was \$ 1.1 trillion by the end of March 2022, up from just \$96 billion in March 2020, making it greater than the total market cap of all automakers in the USA combined. Even though its market value has decreased by 72% from its peak in 2021, as of

30 December 2022, it still has a market capitalization of \$388.97 billion, making it more valuable than Toyota, GM, and Ford put together, which have respective market capitalizations of \$220.45 billion, \$47.79 billion, and \$46.76 billion. During the period Musk became the first person in history to lose over \$200 billion in one year.



The failing economy, rising inflation, a new pandemic in China, and the ongoing conflict between Russia and Ukraine have all been blamed for the shares' sharp decline. According to press sources, manufacturing has been halted at Tesla's Shanghai factory as a result of problems with Covid. Investors believe that Musk's recent entrance into Twitter, where he is directly involved in day-to-day operations, has diverted his attention away from Tesla and is a poor indication for the company. Many naysayers were harsh in their criticism, claiming that the Tesla stock was in a bubble that would eventually burst and that this was only the beginning.

When the industry average PE was 25, Tesla used to trade at an astounding PE of 1401. It is currently trading at a PE of 38.06 as of late December 2022, which is still very expensive when compared to the industry average PE of around 8 in this bear market. The days of Tesla being the only participant in the EV market are long gone, as luxury automobile manufacturers like Mercedes-Benz, BMW, Audi, and others are moving quickly to seize this market, posing stiff competition to Tesla. Tesla's market share, which was 60 percent in 2022, will drop to barely 20 percent by 2025, according to S&P Global analysts. It will be interesting to see how Tesla differentiates itself from its competition given that it is anticipated that all businesses will do all in their power to dominate the EV market.

Looking at Tesla's financials, it generated \$21.45 billion in sales, an increase of +55.95% YoY, and EBIDTA of \$4.64 billion, an increase of +64.91% YoY in Q3'22. Tesla's liquidity ratios, solvency ratios, and profitability ratios don't paint a murky picture with a rising free cash flow each quarter from a \$2.77 billion in Q4'21 to \$3.30 billion in Q3'22, demonstrating a YoY growth of +149.39%. As per the latest study published by Astute Analytica, the EV market is expected to increase from a value of \$229.8 billion in 2021 to \$72,798 billion in 2050 at a CAGR of 21.99% leaving everyone with a plenty of headroom to grow.





As far as Tesla's presence in India is concerned, with the government pushing for the make in India initiative or pay the exorbitant tariffs and taxes, seeing a Tesla driving on our Indian roads in autopilot mode seems like a distant dream but their presence can be felt in Lavelle Road, Ashok Nagar, Bengaluru wherein they have registered its subsidiary.

It will be interesting to see what the future holds for Tesla's investors-green or red in their DMAT accounts, but if you are the car's owner, please keep your hands on the steering wheel even when the autopilot mode is driving you safely to your destination.

IDBI Bank up 5% on SEBI Nod to reclassify Govt. post Sale-Stake as 'public'

Shares of IDBI Bank was up 5 per cent at Rs 57.25 on the BSE in Friday's intra-day trades in an otherwise subdued market after capital market regulator Securities and Exchange Board of India (Sebi) acceded to the central government's request to reclassify shareholding in the Bank disinvestment as "public holding". At 09:22 AM, the stock traded 3 per cent higher at Rs 56.35, as compared to 0.08 per cent decline in the S&P BSE Sensex. The stock hit a 52week high of Rs 61.05 on December 15, 2022.

Low-value payment in digital rupee may be made anonymous

The government may have to frame a law allowing retail users making low-value payments in the recently launched digital rupee to delete the transaction footprint as the central bank digital currency (CBDC) is equivalent to cash that must offer the same degree of anonymity to the bearer, a person with direct knowledge of the matter said.

About 16,000 users have so far made payments worth ₹64 lakh in 160,000 transactions since the launch of the pilot for the digital rupee.

Relying upon a government memorandum from 1907, the Uttarakhand high court (HC) had held that the families in Haldwani had no legal right to the land which they were residing, on notwithstanding the fact that many of these families had been living there for decades, and had title and transfer deeds, and other documentation issued by the government authorities.

TCS Q3 results: Ease in supplysize pressure may lift margins.

All eyes are set on IT-giant Tata Consultancy Services (TCS) which is set to announce its financial performance for the quarter ending December 31, 2022 (Q3FY23) period on January 9. TCS stock will also be in focus during this week's session. TCS which is the largest IT company in terms of market share will be the first to present its Q3FY23 earnings in the sector. In Q3, the company is expected to see improvement in operating margin as supplyside disruption eases. Among key things to watch out for will also be TCS' third interim dividend announcement.

Company FD's offer more return than banks

In comparison to bank fixed deposits, company/corporate fixed deposits provide higher interest rates but also involve a higher level of risk. The Deposit Insurance and Credit Guarantee Corporation (DICGC) covers bank fixed deposits up to ₹5 lakhs, but not corporate fixed deposits; as a result, in the event of defaults, company FDs are impacted. Financial organisations such as non-banking financial companies (NBFCs) and others provide corporate FDs.

Before investing their money, investors should look up the credit rating of these company fixed deposits to determine the legitimacy of the institution.


Jack Ma to give up control of fintech giant Ant Group


