DECODING THE LEGAL JARGONS

ex parte

- (from one party)



In legal ethics, ex parte refers to improper contact with a party or a judge. Ethical rules typically forbid a lawyer from contacting the judge or the opposing party without the other party's lawyer also being present. A breach of these rules is referred to as improper ex parte contact.

In civil procedure, ex parte is used to refer to motions for orders that can be granted without waiting for a response from the other side. Generally, these are orders that are only in place until further hearings can be held, such as a temporary restraining order.

Ex parte judicial proceedings are usually reserved for urgent matters where requiring notice would subject one party to irreparable harm. For example, a person suffering abuse at the hands of a spouse or significant other may seek ex parte a Temporary Restraining Order from a court, directing the alleged abuser to stay away from him or her.

Ex parte judicial proceedings are also used to stop irreparable injury to property. For example, if two neighbors, Reggie and Veronica, disagree over whose property a tree stands on, and Reggie wants to cut down the tree whereas Veronica wants to save it, Veronica can seek an ex parte hearing before a judge. At the hearing, she will ask the judge for a temporary Restraining Order preventing Reggie from felling the tree. She will have to show the judge that she had no reasonable opportunity to provide Reggie with formal notice of the hearing, and that she might win the case. The court will then balance the potential hardships to Reggie and Veronica, in considering whether to grant Veronica's request.

National Update

UP received investment worth 33.5L crore during Global Investors Summit

While asserting that Uttar Pradesh is the safest destination for investments, Chief Minister Yogi Adityanath on Sunday said that investment proposals worth ₹33.5 lakh crore were received at the Global Investors Summit 2023. He also affirmed that unlike earlier when only a few regions around National Capital Region (NCR) got benefits, this year the investment proposals have been made for all 75 districts of the state. The Chief Minister also added that the investment proposals will lead to the creation of 93 lakh employment Opportunities in the state.

Adani Group says balance sheet of companies 'very healthy' and business plan is 'fully funded'

The Adani Group on Monday said that the balance sheet of each of its companies was "very healthy" and that it has strong corporate governance and secure assets. "We have industry-leading development capabilities, strong corporate governance, secure assets, strong cashflows, and our business plan is fully funded," a spokesperson of the group said.

Gautam Adani-led ports-to-power conglomerate has lost about half of its market capitalization due to the heavy selling of shares of its group companies after a stinging report by US-based short seller Hindenburg Research.

India's retail inflation rises to three-month high of 6.52% in January

Higher food prices nudged up India's annual retail inflation in January to a three-month high of 6.52% from a 12-month low in December, showed government data on Monday. It was 5.72% in December and 6.01% in January 2022.

Inflation ran above the upper tolerance limit of 6% for the first 10 months of 2022 but fell below it in the last two, largely because of a fall in food inflation. Food price inflation, which accounts for nearly 40% of the CPI basket, rose to 5.94% in January from 4.19% in December. The prices of cereals and milk continued to rise. The previous high was 6.77% in October.

Budget breather for the RBI: Rate hike cycle is coming to an end

The Union Budget 2023-24 announced by Finance Minister Nirmala Sitharaman has given the Reserve Bank of India (RBI) a bit of a breather. By sticking to a fiscal consolidation road map—where the Budget announced a fiscal deficit target of 5.9 per cent for FY24, and the intent of sticking to the glide path of an under-4.5 per cent deficit by FY26—the Budget has given some cause for the RBI not to worry about the deficit and its impact on inflation. As the Monetary Policy Committee (MPC) of the RBI sits to deliberate on February 6, and announce its decisions on February 8, the backdrop provided by the Union Budget assumes great significance.

Brexit hit UK investment by £29bn, says Bank of England policymaker


Amazon: Unionised Coventry workers announce strike escalation
