

MUNICIPAL FINANCE

- It is field of study of economics, concerned with the financial activities of local government
- It covers the study of laws, institutions, systems and procedures available to local government to generate and use the resources effectively, efficiently and transparently

 There are four pillars of Municipal finance
- 1. Municipal revenue a. Money received from activities of local government
- b. It includes the funds received from other governments like grants, borrows from others.
- 2. Budgeting & Financial Planning: a. To determine the process of how the local Government will raise
- b. utilization of resources in a financial year.
- 3. Expenditure management: To deploy the process & Practices to oversee and control Expenditure on public infrastructure & services
- 4. Financial Accounting & Reporting: Process of recording, analyzing and reporting of Financial transactions of a local government

Major sources of revenue for a municipal authority

- 1. Own sources Taxes & charges directly charges from its customers
- 2. Inter government Transfers Grants (Or) Transfers received from SG/CG
- 3. Debt from government owned institutions, special purpose vehicles/urban

Development funds, Commercial finance, municipal bonds

- 4. Private investment Public private partnership specially used for designing of f certain infrastructure
- 5. Some other sources Value Capture financing, CSR Funding

History: -

In 1992, 74th consecutive amendment act, institutionalized urban local governance framework Like simple;

Union government -> State government -> Local Government - 1. ULB- towns, cities

(India)

(State)

2. Panchayat Raj – villages



LAW:

1. Article 243X:

Empowers the state legislature to authorize Urban local bodies to levy taxes & fees for undertaking developed functions
Assign taxes/fees collected by state to ULB & provide
Grants in aid to assignment ULB finances
2. Article 243W:

It defines powers, authority and responsibilities of ULB to enable them to function as institutions of self government
State can assign 18 functions to ULB as partially or wholly through state legislatures

3. Article 243R:

State may appoint person(s) with special knowledge of municipal administration to represent municipality through state legislature.

TAXES – with each governments

- 1. Union Government Income tax, CGST, Corporate tax
- 2. State government SGST, Stamp duty, Excise, VAT on petroleum
- 3. Local government Property tax, Sanitation tax, administration tax

Responsibilities lies with each government

- 1. Union government Defense, ports, railways, highways, communication
- 2. State Government Public law & order, Public Health & Sanitation, primary education
- 3. Local authority Water supply, urban planning, solid waste management, Sanitation, foot paths, street lights, urban forestry, urban poverty



Life cycle approach to revenue enhancement:

Comprising of 5 stages they are:

- 1. Enumeration: process of identification, creation & Maintenance of records
- 2. Valuation: Methodology by which property value / tariff are determined for Levy
- 3. Assessment: Process of determination of revenue due to be collected from each property/connection
- 4. Billing & Collections: mechanism for billing all recorded properties/connections
- 5. Reporting: System deployed for accurate reporting & timely review for Decision making

Alternate sources of revenue:

- 1. Professional tax
- 2. Bus depot redevelopment complexes, commercial, retail, stores, etc.,
- 3. Waste water processing
- 4. Advertisements displayed on buses, cabs, autos, flyover pillars
- 5. Parking fees fee, fines penalties illegal parking
- 6. Renting play grounds attached to municipal offices for parking.



Trump's Tariff on Indian Exports: What It Means for India's Economy

What Happened?

In early August 2025, former U.S. President Donald Trump imposed a 25% up to a 50% tariff (import tax) on all goods exported from India to the United States. This means every Indian product entering the U.S. will now become more expensive for American buyers. This makes Indian goods less competitive compared to products from other countries.

Trump justified the decision by citing:

- · India's strong trade ties with Russia, including the purchase of oil and weapons.
- · India's membership in BRICS, a group of countries that promotes alternatives to U.S.-led global systems.
- · India's reluctance to open its market fully to U.S. products, especially in the agricultural sector.

This sudden move has caused concern across Indian industries, financial markets, and policymakers.

What Was the Immediate Impact?

Following the tariff announcement:

- · The Indian rupee weakened against the U.S. dollar, reflecting reduced investor confidence.
- · Stock markets fell, especially for companies that rely on exports to the U.S.
- · Exporters became worried about future orders, especially in labor-intensive sectors.

Why Did Trump Target India?

- · This move is not just about economics—it's also about geopolitics. The U.S. wants to pressure India into:
- · Reducing its dependence on Russia for oil and weapons.
- · Avoiding alignment with BRICS, which challenges U.S. financial dominance.
- · Opening up Indian markets more fully for American goods, especially agriculture. India is the only country to receive a full 25% up to a 50% tariff across all products other countries like Vietnam and Brazil received lower rates (10–20%). This shows India is being singled out more aggressively.

What to Watch in the Coming Months

- · Will Trump push for more penalties, especially targeting India's oil imports or defense deals with Russia?
- · Will global companies like Apple or Pfizer adjust their manufacturing or supply chains in India?
- · Can India increase its trade with other countries like the EU, UK, or ASEAN nations to reduce reliance on the U.S.?
- · Will the WTO (World Trade Organization) intervene if India formally challenges the tariffs?

India's Strategic Responses

Diversify trade partners

India will reduce its dependence on the U.S. by boosting trade with the EU, UK, UAE, Southeast Asia, Africa, and Latin America Expanding exports in agriculture, services, and manufacturing to new markets can offset losses.

Strengthen domestic manufacturing

Programs like Make in India and PLI schemes will help industries lower costs, modernize, and become globally competitive. Support through subsidies, tax breaks, and cheaper raw material imports will help exporters weather the tariff shock.



Diplomatic and legal steps

India will continue talks with the U.S., highlight mutual benefits, and may challenge the move at the WTO. It could also impose retaliatory tariffs if needed, while rallying support from G20 and BRICS partners.

Conclusion

The U.S. tariff will make Indian products more expensive in America. This can hurt our exports, reduce jobs in some industries, and slow down the economy a little. But it's also a chance for India to learn and improve—by trading more with other countries, making better quality products, and becoming stronger in global markets.

But this is also a chance for India to do better. India can start selling more to other countries like those in Europe and Asia. This way, we don't have to depend too much on just one country.


It's also a good time for Indian companies to focus on making better products at lower costs. If we make high-quality goods, more countries will want to buy from us.
