## Overview of SICASA Speakers Forum – An initiative of **SICASA Bangalore**

The previous month witnessed the inauguration of first SICASA Speakers Forum at Racecourse Road in the presence of SIRC Chairman, CA Cotha S Srinivas, ICAI Bangalore Chairperson, CA Geetha A B, SICASA Bangalore, Chairman, CA B. T. Shetty and other Chartered Accountants dignitaries who demonstrated the



structure and format of the program as well as took up the challenge of providing guidance and support to the CA Students to meet the objectives of the Forum.

SICASA Speakers Forum, an initiative of SICASA, Bangalore, is a platform wherein CA Students undergoing articleship and/or yet to clear their CA Final Examination participate to develop, build and/or hone their soft skills and professional skills including public speaking skill.

It is a formal program, which runs for six months to a year, every Sunday for 2-3 hours, for a particular set/batch of students. Once they have cleared all the projects (approx. Nine projects), they are deemed to have completed the course and expected to handle the stage anywhere anytime without much fear and nervousness. It is also proposed to provide a Certificate of Participation for regular members who attend the Forum Meetings and complete all the projects.

The program has an identified structure and there are various projects which each of the participants is expected to complete. The program follows bottom up approach i.e. Only after one completes his/her first project, he/she is eligible to move to the next one. Time is a crucial factor during this program and strict adherence to the program schedule and/or agenda is required and expected from all the members. Agenda and other communications are circulated through a designated Whatsapp Group created for the members.

Every meeting will be divided into two sessions viz. Prepared Speech and Butterfly Session. In Prepared Speech Session, students will present their prepared speeches (topics based on the project) for 5-7 minutes. This will be followed by Butterfly Session (aka Table Talk session) where students have to go to the stage and talk upon a particular topic/subject and/or answer the question posed by the Session master. For this, the student will be given 2 (two) minutes time and he/she has to speak for at least one and a half minutes.

These sessions are followed by the Evaluation report presented by the General Evaluator with the help of other individual evaluators, timer and grammarian. The Listener will test the attentiveness of the members by running a short Questions and Answers Session. Presidents' remarks will conclude the meeting with the affirmation to meet again next week with a new agenda and new speeches.

In the above process, there are various roles to be taken up by CA Students. To name a few roles, there is the Master of Ceremony (MC) who will be running the show and giving overall shape to it; Butterfly Session master who will run the Butterfly Session; Timer to take the note of how much time each student/speaker takes on the stage; Grammarian to note best usages of words, phrases and idioms, etc.; Listener to take note of important aspects/gist/events/quotes of the speeches and run a Q&A show towards the end of the session.; etc.

There are also the Office Bearers, under the guidance of the President elected among the members, who will plan the forum meetings, work on the agendas, coordinate with various forum members and new members, disseminate news about the forum, etc. Basically they are the team who do the work behind the scenes apart from their roles at the regular meetings. Manuals for all the office bearers as well as role players (MC, Timer, Grammarian, etc) are already prepared with the help of Chartered Accountants Professionals who are proficient and active in similar kind of Forums/Programmes. Further, guidelines or manual for each individual projects are in the process of formation with manual for Project 1 and Project 2 already finalized. All the roles and speeches are to be taken up as per Role Manuals and the Project Manuals respectively to make the program effective and get the most benefit out of Forum.

Eight meetings of the SICASA Speakers Forum, Racecourse Road have already been completed and CA Students attending the same have found the Forum very interesting and useful. Mr. Gurucharan V (Student), who attended the session for the first time on 19<sup>th</sup> March, 2017, says "This is a very much needed program for CA Students. I don't understand why this was not introduced much earlier." SICASA, Bangalore requested testimonials from few other Forum Members as well as mentors which are re-produced at the end of this article.

At this juncture, I find it imperative to place on record the time and efforts dedicated by CA Ravindranath, Partner, H R A & Co., Chartered Accountants, to provide the guidance for the members of SICASA Speakers Forum. On behalf of all the SICASA Speakers Forum, Racecourse Road, Committee Members, I would like to extend our warm gratitude to CA Ravindranath, SICASA Chairman, CA B. T. Shetty sir and all Chartered Accountants who have volunteered to attend the Forum meetings as the Chief Guest and take up the role of General Evaluator, for their time and support. We hope to have such guidance in upcoming days as well.

As the Vice-President Education of the Forum, I would also like to thank Mr. Sagar Bashyal (President), Mr. Shishir Rijal (Secretary), Mr. Basudev Shrestha (Vice-President Members), Mr. Suman Tiwari (Treasurer), Ms. Ramya B R (Vice-President) and Mr. Dhruv Rathor (Joint Secretary) (SICASA Speakers Forum – Racecourse Road, Committee Members) for their enthusiastic and dedicated efforts to keep the show running.

## Informal Economy: A Hindrance to the Nation's Development

Informal economy, a part of the economy, underlying there, serving a greater portion of the nation yet is not a positive sign for the growth.

When was the last time you went to a shopkeeper and requested some goods? He gave you. You then asked for the bill and he says, "Pay 200 more and take the goods with the



bill, or just take the goods without paying the additional amount and the bill!!!" Now, two prices for the same good. Is that's possible? Yes, it is! The lesser price here forms the part of the informal economy! It goes unaccounted. It goes untaxed! Yes it does give benefit, but, only for a short term and to limited persons! The long term is drastically affected by it.

#### Introduction:

Technically, the Informal economy has three dimensions –

- a) informal establishments or micro enterprises,
- b) informal activities concerning both production and services, and
- c) workers in informal employment

The term "informal", itself, is defined by many people in many ways ranging from simple to complex definitions. The term is also often commutated with the term 'illegal' as many accounts under the informal enterprises are hidden and not maintained transparently. But the informal economy should not be confused with the criminal economy, which deals in illegal goods and services. However, there are activities within the informal economy such as smuggling, drug dealing, trafficking and prostitution, which have clearly illegal ends.

#### Size of the informal economy:

The informal economy is widespread. More than 70 per cent of the economically active population is involved in the informal economy.

#### Area it covers:

Since, the informal economy is widespread; it has covered almost every area. Be it real estate or even a small vegetable.

- Farm and farm related: Self-employed, very small land holders, landless farm workers, tillers, cattle
  herders, former Kamaiyas, Haliyas, daily wage workers, exchange labour under parma tradition and nonregistered large segment of economic activities concerning livestock, poultry, kitchen-gardening dairy,
  fisheries, sericulture, bee farming.
- Trading: Street vendors, Hawkers related to different products including very small traders.
- Craft-workers: Related to clay, metal, bamboo, wood and others.
- Construction: Normally daily wage workers related to building, wood work, road, stone quarrying, and brick-kiln.
- Transport: Porters, cleaners, Khalasi, loaders, Rickshaw pullers, auto-mechanics and helpers.
- Micro enterprise: Family based enterprise workers in various types of production and services.
- Other services: Barbers, cobblers, tailors, blacksmith, traditional entertainers.

#### Reason & Consequences:

Due to changing patterns of employment, the informal economy is rapidly expanding. However, workers in the informal economy face multiple of challenges and constraints because the government is not in a position to regulate it. Consequently, workers are subject to exploitation and deprived of many fundamental rights at work.

Now, one may contend the idea, that vegetable seller... they are informal, yes, what's wrong with that? Yes you are correct! I Yes, one might be correct. But, a rotten potato in the sack rots the whole sack! In the lieu of the correctness of the veggies seller i.e., ok with the informal economy, a major portion of the people, namely business make misuse of this and eventually a major chunk of revenue goes untapped by the government.

#### Consequences:

We get the news every times the budget comes out, the government missed the collecting the targeted revenue. One of the main reasons is being of the economy as informal. We end up cursing the government rather that making a rational thinking, assessing problems and finding solution. A government needs money for different developmental projects. No more money, no more developmental projects.

The same clue applies here as well; the rich going richer, poor becoming poorer. The reason is clearly evident; the presence of informal economy.

The revenue generated out of this economy goes in wrong hands mostly eventually hampering the nation's development.

Peoples' living standards are not elevated. No access to quality education. In most cases the right to education even got compromised. Since many children are also involved in this.

If we talk of health, there is no access to quality health facilities. Government doesn't get proper support from its countrymen and hence confusing its responsibilities, lack of proper health services being one of them.

There is also no access to reasonably priced commodities. The prices of the commodities also get manipulated since being controlled by black marketers.

#### Remedies to it:

- Public Awareness: Public awareness can prove to be a strong tool. We can help contribute spreading public awareness regarding how informal economy is hampering us.
- Suggestion to Government: Through the proper channels we can communicate to government and voluntarily offer ideas and suggestion into tackle this economic stigma
- Financial literacy: We shall conduct events programs with the purpose of sharing financial education. In the recourse, we can also request school and colleges across the country to give extra push in giving the right economic education.
- Some other things we can do: A detailed survey of informal work and employment should be carried out, covering working- and living conditions, so that a broad and nationwide picture will be available on the basis of which strategies, programmes and work-plans could be designed both by the government and non-governmental actors.
- Enterprise development and promotion of entrepreneurship is needed with basic emphasis on micro enterprises.

- · Minimizing exploitative practices and worst forms of labour with particular focus on bondage, debt bonded, child bondage, trafficking and sexual exploitation of women should be a basic objective.
- · Guarantee of minimum wages to workers and ensuring a system of fair wages based on skill and productivity followed by wage indexation initiatives is called for.
- · Vitalising the labour administration and intensification of the labour inspection system would make existing regulation more relevant.

#### **Conclusion:**

The informal economy in Nepal as well as other developing nations is very big and growing. It is transforming itself gradually from subsistence economy to a market based commercialized economy. But still it remains grossly neglected by the state. Government policies and legislation are also becoming void due to enforcement problems.

The major factor behind the low productivity and earnings in the informal sector is the poor support system in terms of technology, training and credit availability, etc. Demand side inventions are neglected in the support system. Each support unit is taken independently instead of a package of support. Lack of upgradation of technology pushes informal activities into a low-equilibrium trap (poor selling to the poor).

The professor picked up a box of sand and poured it into the jar. Of course, the sand filled up the remaining open areas of the jar.


He then asked once more if the jar was full. The students responded with a unanimous "Yes."
