Brief on SA 230: Audit Documentation

"In an Audit, work not documented equals to work not done". This statement clarifies the importance of documentation of any work which we have done.

Documentation here means working papers. Working papers may either be prepared or obtained by an auditor in connection with his audit. It can be clarified with following chart:

These Working papers are the assets of an auditor. No one can access it without the consent of an auditor. Even the client has no authority to access auditor's working papers unless his consent is obtained.

Working papers act as evidences in the court of law. On the basis of working papers an auditor can justify his opinion and safeguard himself.

As per SA 230 read with SQC 1 an auditor should preserve these working papers for minimum period of seven years and it should be preserved in a safe custody so that they can be easily accessed whenever required.

It is the responsibility of an auditor to maintain confidentiality of a client. Hence, he should not disclose any confidential information contained in working paper to a third party unless there is a legal or professional duty to disclose.

Alongside acting as evidence, working papers also help auditors to guide their article assistants, resulting in an enhanced quality of audit as well as development of professional qualities within article assistants.

Board of Studies - Scholarship Scheme

New Initiative - Scholarship to Meritorious students of Senior Secondary Boards:-

The Board of Studies will also grant Scholarship to Meritorious Students of Class 12th:- The candidates who secure first two ranks in various senior secondary boards (from any stream) and join CA course within 1 year of passing class 12th, the course fees Foundation level would be refunded back to them in six equal installments on submission of the prescribed declaration.


Indoor Games Short Review
